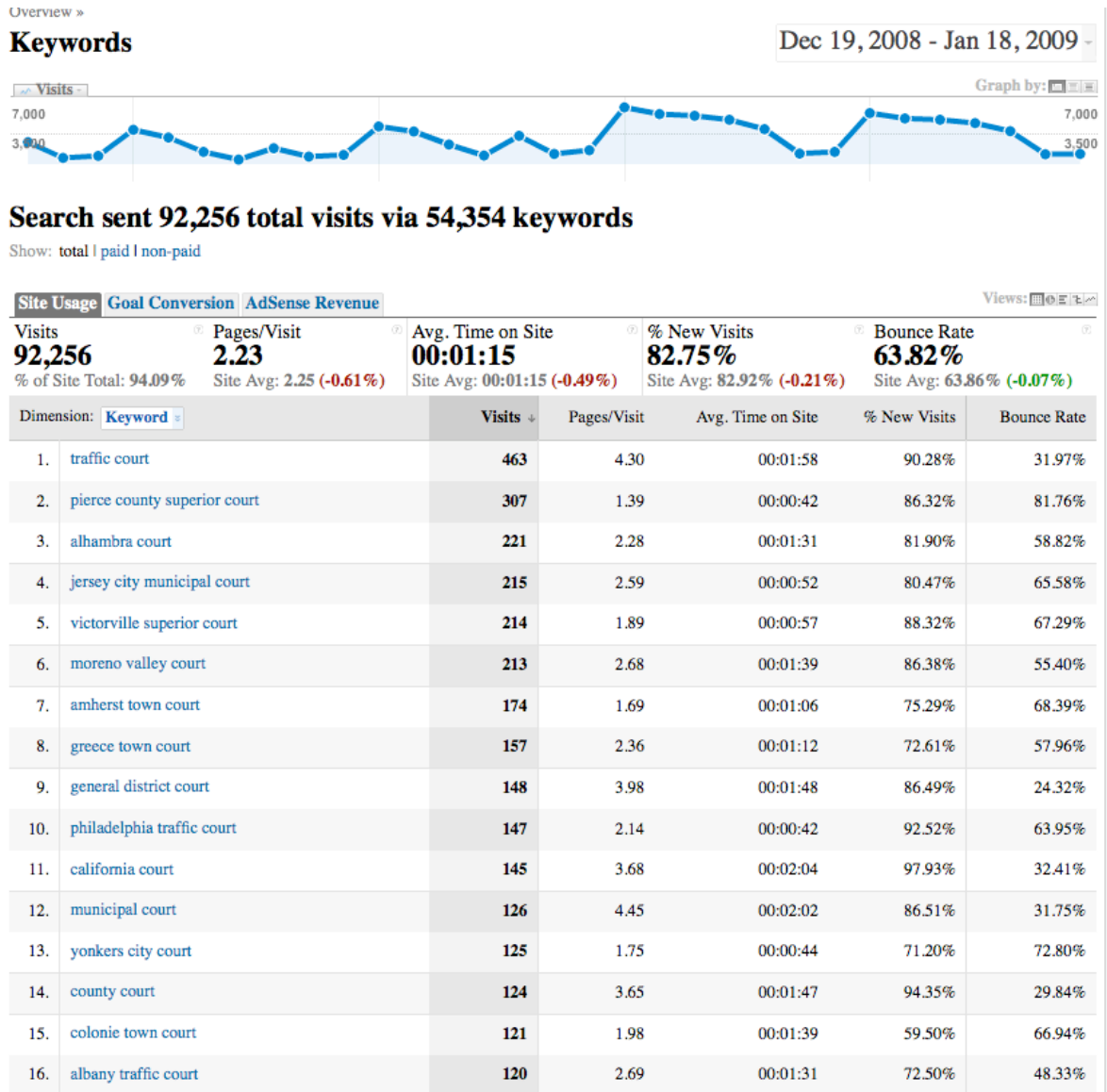

Why They Come

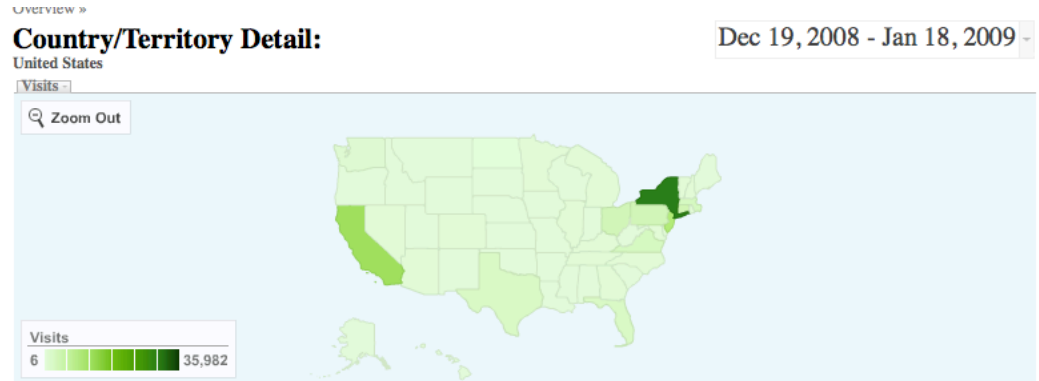
Visitors come to town-court.com primarily from searches. Over the last 31 days there were over 90,000 visits to the site from searches. Most users searched for a court name.

Albany Lawyer Warren Redlich handles traffic tickets in most of upstate New York. The most common cases we see are speeding tickets on interstate highways such as the Thruway (I-90 & I-87), the Northway (I-87 north of Albany), I-81 and I-88.

In nearly all of our cases we negotiate reductions to lesser offenses. The main goal for most clients is to reduce or eliminate the impact on their insurance. This can be tricky with out-of-state drivers and we are familiar with the rules for most nearby states, including New Jersey and Massachusetts. We also have represented a number of drivers from Florida, Ontario, Quebec, and plenty of other states.

In almost all of our cases our client does not have to appear in Court. Our fees for negotiating traffic tickets in most areas start at \$500. Certain factors can increase the fees, especially where the ticket involves a suspension, an accident, high speed, or other complicating factors. In rare cases where a trial is required (mainly in accident cases where there has been an injury, or where the client wants a trial), our fee is at least \$1500 and can easily reach \$2500.

Warren is also a **personal injury lawyer**. He has been handling personal injury cases since 1996, and won a \$3.85 million verdict in 2007 on a motorcycle accident case. Working for Allstate in the late 1990s, Warren was three times named one of their top trial lawyers. Prior results do not guarantee future performance. Finally, Warren handles criminal defense cases in the greater Albany area.

For lawyers, Coeymans Town Court presents a special case in Albany County. While most courts move smoothly and lawyers can get in and out quickly, something else happens here.

The Calendar feature is for members only. Non-members cannot see the calendar at all.

The idea behind it is to help lawyers in two ways. Lawyers who need to find someone to cover for them can check the calendar to see who is going to be in a particular on a particular day.

Lawyers who enter their calendars will thus be able to pick up extra work from lawyers who need coverage.

This feature will become more useful as we increase membership.
